

## **RESOLUTION NO. 2025-072**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A WORK AUTHORIZATION FOR ARCHITECTURE, LANDSCAPE ARCHITECTURE, PLANNING, AND URBAN DESIGN SERVICES WITH CRAVEN THOMPSON & ASSOCIATES, INC. TO PROVIDE ENGINEERING PLAN REVIEW SERVICES FOR THE MAINSTREET PROJECT, IN ACCORDANCE WITH RFQ NO. 10-06-21-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, due to the high number of engineering submittals, the City desires to engage Craven Thompson & Associates, Inc. to perform engineering plan review services for the MainStreet project; and

**WHEREAS**, pursuant to Resolution No. 2022-007, the City has an agreement with Craven Thompson & Associates, Inc. for Architecture, Landscape Architecture, Planning, and Urban Design Services, which includes engineering services; and

**WHEREAS**, Craven Thompson & Associates, Inc. reviewed the City's request and provided a proposal, attached as Exhibit "A," for the engineering plan review services at a cost not to exceed \$70,000; and

**WHEREAS**, the City Commission finds and determines it to be in the best interest of the City to approve a Work Authorization with Craven Thompson & Associates, Inc. for engineering plan review services for the MainStreet project.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached Work Authorization between the City of Coconut Creek and Craven Thompson & Associates, Inc. to provide engineering plan review services for the MainStreet project.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute the attached Work Authorization between the City of Coconut Creek and Craven Thompson & Associates, Inc. for engineering plan review services for the MainStreet project.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
