## **RESOLUTION NO. 2019-019**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ALL **FUTURE** ATTACHED, AND AGREEMENTS. BETWEEN THE STATE OF FLORIDA, DIVISION OF **EMERGENCY MANAGEMENT (FDEM) AND THE CITY OF** COCONUT CREEK **FOR** REIMBURSEMENT OF **EXPENDITURES** INCURRED AS OF HURRICANE IRMA; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, on September 5, 2017, a City-wide state of emergency was declared as a result of Hurricane Irma; and

**WHEREAS**, the City incurred costs associated with debris removal, debris monitoring, protective measures, and permanent work repairs resulting from Hurricane Irma; and

**WHEREAS,** the City submitted a Request for Public Assistance (RPA) to the State of Florida, Division of Emergency Management (FDEM), which was subsequently approved; and

WHEREAS, the City requested reimbursement from FDEM for all federal and state eligible costs associated with debris removal, debris monitoring, protective measures, and permanent work repairs resulting from Hurricane Irma; and

**WHEREAS,** it is in the best interest of the City to enter into the attached, and all future, agreements with the FDEM to receive reimbursement for expenditures related to debris removal, debris monitoring, protective measures, and permanent work repair incurred as a result of Hurricane Irma.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the agreement between the State of Florida, Division of Emergency Management (FDEM) and the City of Coconut Creek for reimbursement of expenditures incurred as a result of Hurricane Irma.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute this agreement, and all future agreements, between the State of Florida, Division of Emergency Management (FDEM) and the City of Coconut Creek for reimbursement of expenditures related to debris removal, debris monitoring, protective measures, and permanent work repairs incurred as a result of Hurricane Irma.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of the resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
