There was no input from the residents.

#### **CITY MANAGER REPORT**

Assistant City Manager Brooks reported that the Hillsboro Boulevard median improvement project was complete and that Cypress Park will be closed through September 1, 2017, to complete the playground replacement.

#### CITY ATTORNEY REPORT

City Attorney Pyburn announced that Assistant City Attorney Eve Lewis would be speaking in front of the Broward County Bar Association Local Government Section on ordinances, resolutions, and proclamations on June 9, 2017.

### **COMMISSION COMMUNICATIONS**

Commissioner Belvedere thanked Police Chief Albert "Butch" Arenal and the Police Department for their excellence in community policing.

Commissioner Welch thanked the staff from Human Resources for attending the Dave Thomas Career Fair. She spoke about several high school graduation ceremonies that she attended and mentioned that the new bi-directional amplifier that the City purchased for Coconut Creek High School was still not installed. She spoke about a group of residents that met to take the Butterfly Express to the Promenade for lunch to encourage residents to use the service.

Commissioner Sarbone spoke about the recent significant rain event and commented that the stormwater system helped minimize the effects of the flooding.

Vice Mayor Rydell spoke about a public safety meeting he hosted for the neighborhoods in the north end of the City and noted that the residents wanted more police officers hired. He thanked the City staff who attended the meeting where they provided information regarding several City services and programs with the residents.

Mayor Tooley spoke about several car burglaries in the South Creek neighborhood and the need for more lighting in the area. She attended the Monarch High School graduation ceremony and the Senior Expo. She asked for consensus to sign the U.S. Climate Mayors statement in support of goals in the Paris Agreement that address climate change on behalf of the City, and consensus was given.

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF COCONUT CREEK BY AMENDING CHAPTER 21, "PERSONNEL ADMINISTRATION," ARTICLE I, "CIVIL SERVICE

CODE," SECTIONS 21-1, 21-2, 21-5, 21-6, 21-8, 21-9, 21-10, 21-11, 21-17, AND 21-18, REPEALING SECTION 21-7, AND AMENDING ARTICLE II, "AT WILL- EMPLOYEE POLICIES AND PROCEDURES MANUAL," SECTIONS 21-19, 21-22, 21-23, 21-24, 21-25, 21-26, AND 21-29 IN ORDER TO PROVIDE REVISIONS TO THE TERMS AND CONDITIONS OF CITY EMPLOYMENT AND PROVIDE CROSS-REFERENCES TO APPLICABLE ADMINISTRATIVE ORDERS.
