RESOLUTION NO. 2024-016

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENTS BETWEEN THE CITY OF COCONUT CREEK AND P.L.A. ELECTRIC. (PRIMARY CONTRACTOR) AND KILOWATT ELECTRIC COMPANY (SECONDARY CONTRACTOR), ATTACHED **HEREOF** AND MADE PART ATTACHMENTS "A" AND "B" RESPECTIVELY. TO PROVIDE ELECTRICAL SERVICES PURSUANT TO IFB NO. 12-13-23-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City's intent of this service contract is to establish an agreement with experienced and qualified firms to provide routine and emergency electrical services on an as-needed basis; and

WHEREAS, the current agreement with P.L.A. Electric, Inc. and Imperial Electrical, Inc. expires on January 23, 2024; and

WHEREAS, on November 12, 2023, the City issued one hundred twenty-nine (129) electronic invitations through the eBid System and received three (3) responsive submittal(s); and

WHEREAS, the Procurement Division reviewed the bid responses for compliance, and no issues were found; and

WHEREAS, based upon the schedule of bid prices outlined in Exhibit "A" of the agreement(s), as well as the information in their bid and the results of the background and reference checks, Public Works staff recommends that P.L.A. Electric, Inc. be awarded as the primary contractor and Kilowatt Electric Company be awarded as the secondary contractor for this service; and

WHEREAS, the initial contract period shall be for three (3) years, beginning upon City Commission approval; and

WHEREAS, the City reserves the right to extend the contract for two (2) additional one (1) year periods, providing both parties agree to the extension; all the terms, conditions and specifications remain the same; and such extension is approved by the City; and

WHEREAS, the City Commission finds and determines that it is in the best interest of the City to enter into agreements with P.L.A. Electric, Inc. and Kilowatt Electric Company to provide electrical services to the City pursuant to IFB No. 12-13-23-11.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the agreements between the City of Coconut Creek and P.L.A. Electric, Inc. (primary contractor), attached hereto and made a part hereof as Attachment "A," and Kilowatt Electric Company (secondary contractor), attached hereto and made a part hereof as Attachment "B," to provide electrical services pursuant to IFB No. 12-13-23-11.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the agreements between the City of Coconut Creek and P.L.A. Electric, Inc. (primary contractor) and Kilowatt Electric Company (secondary contractor) to provide electrical services pursuant to IFB No. 12-13-23-11.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
