

ORDINANCE NO. 2015-033

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AMENDING CHAPTER 2, "ADMINISTRATION", ARTICLE III, "DEPARTMENTS", DIVISION 1, "GENERALLY", SECTION 2-41, "REORGANIZATION OF CITY DEPARTMENTS" TO PROVIDE FOR THE REORGANIZATION OF CITY DEPARTMENTS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Manager has recommended and the City Commission has agreed to the reorganization of certain City Departments; and

WHEREAS, the City Commission desires to update the Code of Ordinances in order to remove obsolete references.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AS FOLLOWS:

**Section 1:** That the Code of Ordinances of the City of Coconut Creek shall be amended by amending Chapter 2, "Administration", Article III, "Departments", Division 1., "Generally", Section 2-41, "Reorganization of City Departments", to read as follows:

**Sec. 2-41. - Reorganization of eCity dDepartments.**

(a) ~~Existing departments eliminated; exception.~~ All existing city departments are hereby eliminated, except for the public safety department.

(b)(a) *Departments created.* There is hereby created the fFinance and aAdministrative sServices dDepartment, the development services department and the pPublic services Works dDepartment, the City Attorney Department; the City Clerk Department; the City Commission Department, the City Manager Department; the Fire Administration Department; the Human Resources and Risk Management Department; the Information Technology Department; the Parks and Recreation Department; the Police Department; the Sustainable Development Department; and the Utilities and Engineering Department. In this code, any references to the former community development department the former Development Services Department or function shall be replaced with the development services department the Sustainable Development Department; any references to the former eEngineering dDepartment or function shall be replaced with the development services department the Utilities and Engineering Department; any references to the former public works department the former Public Services Department or function shall be replaced with the public services department the Public Works Department; any references to the former eCommunity sServices dDepartment or function shall be replaced with the public services department the Public Works Department; any references to the former uUtilities dDepartment or function shall be replaced

with the ~~public services department~~ the Utilities and Engineering Department; any reference to the former Information Systems Department or function shall be replaced with the Information Technology Department.

(e)(b) *Establishment of duties and functions by eCity mManager.* The duties and functions of the new eCity dDepartments shall be established and determined at the discretion of the eCity mManager.

**Section 2: Conflict.** All ordinances or parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions or parts of resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 3: Severability.** That should any section or provision of this Ordinance or any portion thereof, any paragraph, sentence, clause or word be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remainder hereof as a whole or part hereof other than the part declared invalid.

**Section 4: Codification.** That the provisions of this Ordinance shall be codified within the Code of Ordinances of the City of Coconut Creek, Florida, and any paragraph or section may be renumbered to conform with the Code of Ordinances.

**Section 5: Effective Date.** That this ordinance shall become effective upon its passage on second and final reading.
