A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO EXECUTE A RIGHT-OF-WAY MAINTENANCE AGREEMENT ATTACHED HERETO AND MADE A PART HEREOF, BETWEEN THE CITY OF COCONUT CREEK AND VRS/BROADSTONE CYPRESS HAMMOCKS, LLC, FOR IMPROVEMENTS TO BE INSTALLED AND MAINTAINED ALONG N.W. 51<sup>ST</sup> TERRACE; PROVIDING AN EFFECTIVE DATE

WHEREAS, the City is desirous of entering into a Right-of-Way Maintenance Agreement with Broadstone wherein Broadstone agrees to perform and take all action necessary, at no cost to the City, to install and maintain improvements to be located in City right-of-way, on N.W. 51<sup>st</sup> Terrace, and more particularly described in Exhibit "A", attached hereto.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the City Commission has reviewed and hereby approves the attached Right-of-Way Maintenance Agreement between the City and VRS/Broadstone Cypress Hammocks, LLC, to install and maintain improvements to be located in City right-of-way along N.W. 51<sup>st</sup> Terrace.

Section 2: That the City Manager is hereby authorized to execute said Maintenance Agreement.
