## **RESOLUTION NO. 2024-029**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT BETWEEN THE CITY AND STAGE PRO AUDIO CORPORATION DBA STAGE DIGITAL ADVISORS TO DESIGN, PURCHASE, INSTALL, REPAIR, AND MAINTAIN AUDIO/VISUAL SOUND EQUIPMENT PURSUANT TO RFP NO. 10-11-23-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City issued Request for Proposals (RFP) No. 10-11-23-11 to contract with a qualified vendor to design, purchase, install, repair, and maintain audio/visual sound equipment at various City locations; and

WHEREAS, on September 10, 2023, the City issued ninety-eight (98) invitations through the eBid System and received one (1) responsive submittal, which was evaluated by a selection committee consisting of Todd Edge, Public Works Project Manager; Lenore Thomas, Parks and Recreation Superintendent; and Justin Zeller, Public Works Electrician; and

**WHEREAS**, the proposal was evaluated based on criteria stated in the RFP document, the scope of services proposed, reference checks, and experience; and

**WHEREAS**, the selection committee reviewed Stage Pro Audio Corporation DBA Stage Digital Advisors proposal and determined the vendor is capable of performing the scope of services outlined in RFP No. 10-11-23-11; and

**WHEREAS**, the initial contract term shall be for one (1) year, or until work is completed whichever is later, with the right to extend the contract for one (1) additional one (1) year period.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Stage Pro Audio Corporation DBA Stage Digital Advisors to design, purchase, install, repair, and maintain audio/visual sound equipment pursuant to RFP No. 10-11-23-11.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and Stage Pro Audio Corporation DBA Stage Digital Advisors to design, purchase, install, repair, and maintain audio/visual sound equipment pursuant to RFP No. 10-11-23-11.
