

RESOLUTION NO. 2021-063

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A CONSULTING SERVICES WORK AUTHORIZATION WITH KCI TECHNOLOGIES, INC. TO PROVIDE DESIGN SERVICES FOR IRRIGATION AND LANDSCAPE IMPROVEMENTS WITHIN THE LYONS ROAD MEDIANS BETWEEN COCONUT CREEK PARKWAY AND ATLANTIC BOULEVARD IN THE AMOUNT OF \$79,920; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has budgeted for the design of irrigation and landscape improvements for the Lyons Road medians between Coconut Creek Parkway and Atlantic Boulevard; and

WHEREAS, the Lyons Road medians between Coconut Creek Parkway and Atlantic Boulevard are the last remaining segment of Lyons Road within the City to be improved; and

WHEREAS, the irrigation system that was originally installed in these medians is at the end of its useful life, experiencing significant downtime, and requiring constant maintenance and repairs; and

WHEREAS, the design of a new system is necessary to improve efficiency, reduce consumption and downtime, and ensure the survivability of landscape improvements; and

WHEREAS, the City has an approved Architecture, Landscape Architecture, and Urban Design Services Agreement with KCI Technologies, Inc. to provide for the design of the aforementioned irrigation and landscape improvements; and

WHEREAS, KCI Technologies, Inc. has submitted a proposal to provide the requested services in the amount of \$79,920; and

WHEREAS, staff recommends approval of a Consulting Services Work Authorization with KCI Technologies, Inc. to provide the aforementioned services; and

WHEREAS, the City Commission of the City of Coconut Creek finds and determines it to be in the best interest of the City and its residents to approve a Consulting Services Work Authorization with KCI Technologies, Inc. to provide the aforementioned design for Lyons Road Median Improvements in the amount of \$79,920.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the attached Consulting Services Work Authorization between the City of Coconut Creek and KCI Technologies, Inc. to provide the necessary design services for Lyons Road Median Improvements between Coconut Creek Park and Atlantic Boulevard in the amount of \$79,920.

Section 3: That the City Manager, or designee, is hereby authorized to execute said Consulting Services Work Authorization between the City of Coconut Creek and KCI Technologies, Inc.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
