## **RESOLUTION NO. 2019-300**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE **USE OF FEDERAL LAW ENFORCEMENT TRUST FUNDS** IN THE AMOUNT OF \$239,500 FOR THE PURCHASE OF RAPID ID FINGERPRINT SCANNERS, VEHICLE ALARMS, HONOR **GUARD** UNIFORMS, CJIS **COMPLIANCE** SOFTWARE, SPECIAL WEAPONS AND TACTICAL TEAM EQUIPMENT, SALARIES FOR SCHOOL RESOURCE OFFICERS FOR FISCAL YEAR 2020, CAPITAL OUTLAY FOR NEW POSITIONS FOR FISCAL YEAR 2020: AUTHORIZING USE OF LOCAL THE ENFORCEMENT TRUST FUNDS IN THE AMOUNT OF \$45,000 FOR THE PURCHASE OF ALCOHOL BREATH TEST SIMULATORS, CRASH DATA RETRIEVAL UNITS, AND TO PROVIDE A DONATION TO THE POLICE EXPLORER POST; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek has established a Federal Law Enforcement Trust Fund for the receipt and disbursement of forfeiture monies, pursuant to the Federal Department of Justice Agreement, and a Local Law Enforcement Trust Fund for receipt and disbursement of forfeiture monies, pursuant to Section 932.7055, Florida Statutes; and

**WHEREAS**, the Chief of Police has requested that the City Commission make an appropriation from said funds; and

WHEREAS, the funds from the above request will be utilized for law enforcement purposes, including the purchase of rapid ID fingerprint scanners, vehicle alarms, honor guard uniforms, CJIS compliance software, special weapons and tactical team equipment, salaries for School Resource Officers for Fiscal Year 2020, capital outlay for new positions for Fiscal Year 2020, alcohol breath test simulators, crash data retrieval units, and a donation to the Police Explorer Post; and

**WHEREAS,** this appropriation of funds complies with the requirements of the State of Florida Forfeiture Guidelines and/or the Department of Justice/Treasury Forfeiture Guidelines.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

<u>Section 2:</u> That the City Commission hereby approves the appropriation of Two Hundred Thirty-Nine Thousand, Five Hundred Dollars (\$239,500) from the Federal Law Enforcement Trust Fund for rapid ID fingerprint scanners, vehicle alarms, honor guard uniforms, CJIS compliance software, special weapons and tactical team equipment, salaries for school resource officers for Fiscal Year 2020, capital outlay for new positions for Fiscal Year 2020, and Forty-Five Thousand Dollars (\$45,000) from the Local Law Enforcement Trust Fund for alcohol breath test simulators, crash data retrieval units, and a donation to the Police Explorer Post.

**Section 3:** That the City Commission hereby authorizes the City Manager, or designee, to proceed with the above expenditure from forfeiture funds.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
