A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AMENDING RESOLUTION NO. 2001-156, WHICH WAS AMENDED BY RESOLUTION NOS. 2006-96, 2006-121, 2007-111, AND 2012-09 WHICH RESOLUTIONS ESTABLISHED THE SALARIES AND BENEFITS OF THE MAYOR AND COMMISSIONERS; BY PROVIDING THAT MEMBERS OF THE CITY COMMISSION ARE ELIGIBLE FOR THE SECTION 125 CAFETERIA PLAN CITY CONTRIBUTIONS PROVIDED TO GENERAL CITY EMPLOYEES; PROVIDING AN EFFECTIVE DATE

WHEREAS, Article III, Section 303 of the Charter of the City of Coconut Creek provides that the City Commission shall have the power to periodically establish the annual salaries of its members and to establish expenses and benefits for the City Commission; and

WHEREAS, the City Commission wishes to continue participation in the Section 125 Cafeteria Plan made available to City employees in the same amount as general City employees; and

WHEREAS, the City Commission wishes to provide a payment for those Commissioners who opt out of the City's medical insurance;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That Resolution Nos. 2001-156, 2006-96, 2006-121, 2007-111, and 2012-09, which Resolutions established the salaries and benefits of the Mayor and City Commission, are hereby amended as provided by the provisions of Sections 2 and 3, below.

<u>Section 2:</u> That the City Commission of the City of Coconut Creek, Florida, hereby reaffirms that Elected Officials are eligible to participate in the City's Section 125 Cafeteria Plan under the same terms and conditions as general City employees.

<u>Section 3:</u> That Elected Officials who opt out of the City's medical insurance plan and show proof of other medical insurance are eligible to receive a payment equal to the minimum amount contributed by the City for general employee single medical insurance coverage paid out in the same manner as City employees are paid.
