RESOLUTION NO. 2020-214

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A SINGLE SOURCE AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND MACH ALERT, INC. THE FOR INSTALLATION OF FIRE STATION ALERTING HARDWARE AND SOFTWARE IN FIRE STATIONS 50, 94, AND TEMPORARY FIRE STATION 113; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Mach Alert, Inc. has provided fire station alerting hardware and software to the City of Coral Springs; and

WHEREAS, Mach Alert, Inc. is the only hardware and software that is used by Coral Springs 911 dispatch to alert the fire stations in Coral Springs; and

WHEREAS, the City of Coconut Creek has contracted the City of Coral Springs to provide fire/EMS dispatch services to Coconut Creek Fire Rescue; and

WHEREAS, it is necessary to enter into a single source agreement for Mach Alert, Inc. to install fire station alerting hardware and software in the Coconut Creek fire stations to meet the City's needs to provide fire/EMS services; and

WHEREAS, these needs include Fire Station 50, 94, and temporary Fire Station 113 being equipped with necessary hardware and software to be alerted for 911 calls from Coral Springs dispatch, meeting the applicable NFPA 1221 standards on fire department alerting and allowing for timely response to fire/EMS calls; and

WHEREAS, the agreement provides for the installation of hardware and software in the three Coconut Creek fire stations. The agreement amount will be \$116,714 and will be completed by December 31, 2020; and

WHEREAS, single source agreement purchases exceeding \$50,000 require City Commission approval; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to enter into a single source agreement with Mach Alert, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE **CITY OF COCONUT CREEK, FLORIDA:**

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

Section 2: That the City Commission has reviewed and hereby approves the single source agreement between the City of Coconut Creek and Mach Alert, Inc. providing for the installation of fire station alerting hardware and software in the three Coconut Creek fire stations, attached hereto as Exhibit "1."

That the City Manager, or designee, is hereby authorized to execute said agreement between the City of Coconut Creek and Mach Alert, Inc. for the installation of fire station alerting hardware and software.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

That this resolution shall be in full force and effect immediately upon Section 5: its adoption.
