CITY OF COCONUT CREEK TREE CANOPY REPLACEMENT GRANT PROGRAM GUIDELINES

Purpose

The purpose of the Tree Canopy Replacement Grant Program is to assist eligible applicants with tree canopy replacement in neighborhoods that have lost canopy due to hurricane damage, disease, or other natural impacts. The City's mission is to provide exceptional, responsive, and sustainable services for the Coconut Creek community. Quality neighborhoods are crucial to attaining our mission. The state of our neighborhoods reflects the City's overall economic stability, social quality, and security.

When any living tree, as determined by the Department of Sustainable Development, is removed, regardless of the condition, a Tree Removal Permit (TRP) is required unless an exemption is noted in the Land Development Code. Upon tree removal, canopy replacement is mandated by Broward County and City Code. Replacement is 1:1 for palm and street trees. All other tree replacement is based on the existing canopy square footage being removed from a site as prescribed in the code, so that there is no overall canopy loss on site. So as not to increase the financial burden our residents are already experiencing due to ever increasing property insurance, legislative mandates, and other inflationary costs burdening the City's neighborhood, condominium and homeowners' association managed communities, the City proposes to reimburse a portion of the costs of tree canopy replacement.

Eligible Applicants

The types of individuals or organizations eligible for funding include the following:

Neighborhood Associations – Voluntary, non-profit organizations formed by residents of a subdivision. The goal of these organizations is to enhance and preserve the quality of the neighborhood. Neighborhood associations have no regulatory powers.

Condominium (CA) and Homeowners Associations (HOA) – Mandatory organizations for all property owners within the boundaries of a development, including condominium and townhome associations. Homeowners Associations have legal authority to enact and enforce maintenance and design standards and levy fees for maintenance of common areas. This type of organization is formed as a part of the development process of new neighborhoods prior to actual construction.

Eligible Projects

The grant program is designed to provide funding assistance for tree canopy replacement projects to promote a more robust, safe, beautiful, and sustainable community. This grant is not intended to pay for the cost of tree removal under any category. Eligible tree canopy replacement projects include the following activities:

1. **1-2 Diseased Tree:** Replacement of trees where disease has been demonstrated by a certified arborist's report or the City's Urban Forester as the source of the tree's ultimate demise. In such case, the applicant is responsible for the total cost of the replacement tree(s) and the grant will reimburse the cost for the remainder of the required canopy replacement, as determined by the Land Development Code, up to the limit of this grant. In the case of the loss of more than two trees under this category, the event will fall under category four as outlined in this grant program.

2. **1-2 City Infrastructure and Sidewalk Conflicts (not street trees):** Replacement of tree canopy where a certified arborist or the City's Urban Forester demonstrates that further growth will affect City infrastructure or a community sidewalk. In such case, the applicant is responsible for the total cost of the replacement tree(s) and the grant will reimburse for the cost of the remainder of the required canopy replacement, as determined by the Land Development Code, up to the limit of this grant. In the case of the loss of more than two trees, the event will fall under category four as outlined in this grant program.
3. **1-2 Street Tree/Palm Replacement:** A project providing street tree replacement when applying the "Right Tree, Right Place" concept. Proposed street tree removal must follow City tree removal guidelines and codes, must utilize a new Street Tree Plan (available through the Neighborhood Enhancement Grant Program) approved by the City, or utilize the landscape waiver process to alter the approved street tree for the location or community. Any proposed removal must also have a Tree Removal Permit (TRP) and meet the requirements of the TRP. Due to the historic practice of street trees being a 1:1 replacement, this category is a 50% matching grant with limits noted under "Terms of Agreement". In the case of the loss of more than two trees, the event will fall under category four as outlined in this grant program.
4. **Multiple or Catastrophic Tree/Palm Loss:** Replacement of the loss of multiple (more than two) palms or trees, or loss due to a catastrophic event, such as a widespread pathogen or infestation, hurricane, lightning, or other natural disasters. Upon demonstration by a certified arborist or the City's Urban Forester that a tree or palm is a loss or must be removed due to one of the reasons listed in the above categories, an eligible applicant may apply for the grant under this category.
 - a. **Trees:** The applicant is responsible for the total cost of the replacement tree(s) and the City will reimburse 50% of the cost for the remainder of the required tree canopy replacement, or required trees per code or approved landscape plan, as determined by the Land Development Code, up to the limit of this grant.
 - b. **Palms:** Palms are 1:1 replacement. The City will reimburse 50% of the cost of the requested replacement up to the limit of this grant.

Funding Criteria

This program shall be funded through the City's Tree Preservation Trust Fund, as outlined in Section 13-448 of the City's Land Development Code or as directed by the City Commission. The funds shall solely be used for planting trees in Coconut Creek and any other ancillary costs associated with planting trees.

Each project will be evaluated based on how well it addresses the Tree Canopy Replacement Grant Program's primary purpose of maintaining tree canopy in neighborhoods and the community. When there are more projects requested than funding can accommodate, projects that accomplish the following goals are in priority order below:

1. Catastrophic events due to natural disasters.
2. Catastrophic events due to disease or infrastructure issues.
3. Diseased trees/palms and infrastructure conflicts under categories 1, 2, & 3.

Funding Restrictions

The cost estimates for the replacement canopy shall represent fair market value as defined in the City's code. An applicant who has previously received funds will not be eligible to receive additional funds for five (5) years unless:

1. No other applicants meet the criteria and/or funding requirements.
2. It is a multiple Neighborhood Association or HOA/CA project that will require all neighborhood associations or HOAs to apply, including previously funded associations, to implement the proposed project.
3. The City Manager, or their designee, may alter funding restriction requirements after a natural disaster in the community, such as but not limited to, a hurricane or tornado.

Funding at or under \$5,000 may be approved by the City Manager or designee. Funding greater than \$5,000 must be approved by the City Commission.

Application Requirements

The applicant must submit the required application form with a complete project description. The application must include all of the following listed items:

1. Contact names, email addresses, and telephone numbers of the individuals or members who have the authority to act on behalf of the association/organization, if applicable;
2. Project description;
3. Project justification, including a certified arborist's report if obtained or required by the City;
4. A complete Tree Removal Permit Application (available online);
5. Letters of authorization, where applicable, from the HOA/CA;
6. Board minutes showing approval of the described project and funding commitment, if applicable;
7. Landscape plans, where applicable, which include tree locations, quantities, species, sizes, and nursery grade;
8. Scope of services, and contract
9. Organization's W-9, if applicable.

Application

All applications must be submitted on approved application forms, which may be obtained by contacting the Department of Sustainable Development at City Hall or calling 954-973-6756.

Applications will be accepted year-round, when funding is available. Funds will be awarded to completed and approved applications on a first-come, first-served basis. The Program will be assessed for funding each Fiscal Year, which begins October 1st. Any applications not funded within a fiscal year may be held for consideration for the following fiscal year, if funds are available. Any held applications will be considered above new applications, within the parameters of the "Funding Criteria" of this Program.

Selection/Notification

Applications will be reviewed by Sustainable Development staff to ensure that the minimum criterion has been met. Any applicant that does not meet the minimum criteria will be notified. The applications deemed complete and eligible will be submitted for final approval and funding, as applicable.

Terms of Agreement

Grant Limits:

	<u>Maximum Grant Amount</u>
1. Tree Canopy Replacement, Disease:	\$20,000
2. Tree Canopy Replacement, Infrastructure Conflict:	\$20,000
3. Street Tree Replacement:	\$20,000
4. Multiple/Catastrophic Palm or Canopy Replacement:	\$30,000

Term:

1. Funds must be expended within nine (9) months of the award.
2. Extensions may be granted by the City Manager, or designee, for up to one (1) additional year.
3. The City Manager, or their designee, may alter funding restriction requirements after a natural disaster in the community, such as but not limited to, a hurricane or tornado.

Project Completion and Reimbursement

Upon project completion, an applicant must complete and submit the following items to be eligible for reimbursement:

1. Final inspection by City staff;
2. Photographs of the project area;
3. Invoices of actual costs;
4. Affidavit of continued maintenance for the newly planted trees/palms. Future funds will not be granted for the replacement of trees due to failure of proper maintenance of trees funded by this grant program.
