

**RESOLUTION NO. 2023-186**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, ADOPTING THE CITY'S PUBLIC TRANSPORTATION AGENCY SAFETY PLAN (PTASP) FOR THE BROWARD COUNTY TRANSIT COMMUNITY SHUTTLE PROGRAM; AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE ALL NECESSARY PTASP CERTIFICATION FORMS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Coconut Creek's public transportation program currently makes eighteen (18) passenger trips per day on average; offers a North and a South Bus Route, which provides transportation for a wide range of trip purposes that include: medical, nutrition, shopping, social service, training, employment, social, and recreation; and uses three (3) primary shuttle buses and two (2) spares, all of which are equipped for wheelchair service; and

**WHEREAS**, in order to provide such services, the City relies heavily on federal funds distributed by the Federal Department of Transportation to Broward County, and then to the City as a sub-recipient; and

**WHEREAS**, Broward County requires all cities receiving federal funds in the County to adopt the Public Transportation Agency Safety Plan (PTASP) on an annual basis to continue to be eligible for federal funding pursuant to the Federal Transit Administration (FTA) requirements contained in 49 C.F.R. Part 673; and

**WHEREAS**, the City Commission of the City of Coconut Creek finds and determines that approval of the PTASP is in the best interest of the residents, business owners, and travelers throughout Coconut Creek.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

Exhibit "A," attached hereto, is incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission hereby formally adopts the Public Transportation Agency Safety Plan, attached hereto and incorporated herein as Exhibit "A."

**Section 3:** That the City Manager, or designee, is hereby authorized to execute all necessary Public Transportation Agency Safety Plan certification forms.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
