
To the extent practicable, board appointments shall be based on the applicant's participation or employment in groups or organizations within the City or County active in crime prevention or drug use prevention or treatment.

I saw your ad for help on a City Board in the Coconut Creek Lifestyle. I wish to apply for two of the committees. They are the Educational Advisory Board and the Community Outreach Board.

I had lived as a "snow bird" in Coconut Creek for at least 12 years and moved down from New York about 4 years ago. I am now a permanent member of the Coconut Creek population. My former profession was as a certified para-legal for the last 35 years. The last 15 was with the same law firm, Kaplowitz & Galinson, Esq.
