A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AMENDMENT NO. 3 TO THE AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND EDJ SERVICE, INC. FOR THE PURPOSE OF ADDING ADDITIONAL PROPERTIES AND SERVICES THAT WERE NOT PART OF THE ORIGINAL AGREEMENT AND UPDATING THE COMPENSATION ACCORDINGLY; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek ("City") entered into an agreement with EDJ Service, Inc. on September 12, 2013, for landscape maintenance services pursuant to RFP No. 07-23-13-10; and

WHEREAS, the City approved Amendment No. 1 to the Agreement on January 13, 2015, to add landscape maintenance services for the Coconut Creek High School Lake Bank; and

WHEREAS, the City approved Amendment No. 2 on August 11, 2016, to add landscape maintenance services related to improvements on Coconut Creek Parkway, Copans Road, and Lyons Road; and

WHEREAS, since the prior Amendment, the City has made landscaping improvements along Hillsboro Boulevard and purchased two (2) properties adjacent to Oak Trails Park; and

WHEREAS, the aforementioned Agreement needs to be amended to reflect the above mentioned changes and associated costs; and

WHEREAS, funding in the amount of \$15,430.00 is budgeted for said purpose; and

WHEREAS, staff recommends approval of Amendment No. 3 to the Agreement between the City of Coconut Creek and EDJ Service, Inc.; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the residents of Coconut Creek to approve Amendment No. 3 to the Agreement between the City of Coconut Creek and EDJ Service, Inc. for the additional landscape maintenance services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2: That the City Commission has reviewed and hereby approves the attached Amendment No. 3 between the City of Coconut Creek and EDJ Service, Inc.

Section 3: That the City Manager, or designee, is hereby authorized to execute said Amendment by and between the City of Coconut Creek and EDJ Service, Inc.

<u>Section 4:</u> That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall become effective immediately upon its adoption.
