- <u>DV</u> (initial) 10 DAY QUOTE: This quote is valid for 10 days. Prices and availability may be impacted by Supply Chain instability after 10 days from the quote date. Quote prices are locked-in when the estimate is converted to an order.
- <u>DV</u> (initial) DEPOSIT: When your credit card is on file in our order system, we will work with you to create artwork layouts. Please call with your credit card number to initiate your order in our design que. After we have your artwork approval, we will charge a 50% deposit to produce your order. The balance of your order will be due upon pick-up or installation, we accept cash, check, credit card.
- <u>DV</u> (initial) DESIGN FEES: Design and layout will begin after the order is initialized in our system. Additional design charges will be required if logo, file, or picture editing, is necessary and/or commercial photos/artwork needs to be purchased.
- DV (initial) DESIGN REVISIONS: This estimate includes up to 3 artwork revisions during the design stage, additional revisions may be charged by the design hour. If the project is cancelled during or after the design phase, then design charges will be due and payable.
- <u>DV</u> (initial) CUSTOMER SUPPLIED ARTWORK: Customer supplied files must meet the minimum size, resolution, and file type requirements, for use in your project. Small files, under 3MB, are typically not usable for large format design. Vector files (.ai .eps .svg or vectorized .pdf) will typically work well. Non-vector files (.jpg .gif .tiff .png) will require additional design time fees to be applied to your project.
- DV (initial) INSTALLATION READINESS: Installation quotes are based on the ready to apply condition of the application surface. All walls, windows, vehicles, or other surfaces must be clean and in good repair. Cleaning and preparation fees will be added to the invoice if surfaces are not ready for sign or graphics installation.
  - <u>DV</u> (initial) COMPLETION DATES: Project completion is based on a calculation from the date of 'final' client artwork approval.

    Note: Unpredictable Supply Chain Issues may impact project completion date at any time.
- DV (initial) LATE FEES: A 10% late fee will be added to overdue invoices, additional fees of 20% will be added to invoices 30 days past due. All signs and related products described above are the sole property of the All Venue Graphics and Signs until all money owned under this agreement is paid in full. Client will provide access to said signs if payment is not made in full when due. Client agrees to pay all attorney's fees, collection costs, and other related expenses incurred by All Venue Graphics and Signs in an effort to collect any money due under the payment terms of this agreement.
- DV (initial) INDEMNIFICATION: Client indemnifies All Venue Graphics and Signs against any claim by any property owner, landlord, tenant, or any other party that the ordered signs, materials or services may violate. This includes any agreements the client may have with said parties or where such signs, materials or services are not properly authorized by the parties and where their authorization is required.
- DV (initial) ARTWORK APPROVAL: Customer must approve all artwork and materials prior to start of production. If the customer does not approve the designs and materials within 10 days of artwork receipt, then All Venue Graphics and Signs may adjust the price based on the current material costs.
