RESOLUTION NO. 2023-153

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED INTERAGENCY AGREEMENT BETWEEN THE HILLSBOROUGH COUNTY SHERIFF'S OFFICE AND THE CITY OF COCONUT CREEK TO PROVIDE FOR THE SHARING OF LICENSE PLATE RECOGNITION EXTRACT FILES BETWEEN THE PARTIES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Coconut Creek Police Department (CCPD) and the Hillsborough County Sheriff's Office (HCSO) are both criminal justice agencies; and

WHEREAS, both agencies desire to continue to share License Plate Recognition (LPR) data for criminal justice purposes in the interest of public safety; and

WHEREAS, by signing this agreement, the City of Coconut Creek will be able to continue to share LPR information with HCSO.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

- **Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.
- <u>Section 2:</u> That the City Commission has reviewed and hereby approves the Interagency Agreement between the Hillsborough County Sheriff's Office and the City of Coconut Creek for information sharing and use of LPR extract files for criminal justice purposes.
- **Section 3:** That the City Manager, or designee, is hereby authorized to execute said Interagency Agreement.
- <u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.
- **Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
