1. 17-049 ELECTION RESULTS - MARCH 14, 2017, MUNICIPAL ELECTION.

City Clerk May reported the receipt of the certified election results from the Broward County Supervisor of Elections. She read the detailed results into the record, which included Mikkie Belvedere being reelected unopposed for the District B seat; Sandra (Sandy) L. Welch winning the election for the District C seat; and Joshua David Rydell being re-elected unopposed for the District E seat.

Mayor Mikkie Belvedere, Vice Mayor Joshua Rydell, and Commissioner Sandra L. Welch were sworn into office by Judge John D. Fry of the 17th Judicial Circuit Court of Florida.

CITY MANAGER REPORT

City Manager Blasi congratulated Commissioner Welch, Commissioner Belvedere, and Vice Mayor Rydell for their re-election and Mayor Tooley for her appointment as Mayor. She thanked Commissioner Belvedere for her contributions as Mayor during the previous year.

CITY ATTORNEY REPORT

City Attorney Pyburn also congratulated Commissioner Welch, Commissioner Belvedere, Vice Mayor Rydell, and Mayor Tooley.

COMMISSION COMMUNICATIONS

Commissioner Belvedere thanked the Commission for a great year. She spoke about World Water Day and the importance of improving water quality. She asked for consensus to attend the National League of Cities Leadership Summit in October, and consensus was given.

Mayor Tooley asked for consensus to attend the National League of Cities City Summit in November, and consensus was given.

Commissioner Welch spoke about the election and thanked the voters who participated. She attended the School Advisory Council meeting at Atlantic Technical College and noted that magnet school attendance was down because the minimum grade point average was raised. She reported that until revenues at the school increase, the campus would be closed on Saturdays and a hiring freeze was being implemented.

Commissioner Sarbone recognized the Commissioners who were re-elected and commented that it was a testament to their dedication to the City. He congratulated Mayor Tooley and wished her well during her term as Mayor.

8. ORD 2017-007

AN ORDINANCE AMENDING ORDINANCE NO. 2016-47 TO EXTEND THE TEMPORARY MORATORIUM ON THE SUBMITTAL, PROCESSING, AND ISSUANCE OF LOCAL BUSINESS TAX RECEIPTS AND/OR LAND USE APPROVALS FOR MARIJUANA DISPENSING ORGANIZATIONS/MEDICAL MARIJUANA TREATMENT CENTERS FOR NINETY (90) DAYS AS CONTEMPLATED IN THE ENACTING ORDINANCE. (SECOND READING)(PUBLIC HEARING)

City Attorney Pyburn read the Ordinance title into the record.

MOTION: Welch/Rydell – To adopt Ordinance No. 2017-007.

City Attorney Pyburn presented the item.

Mayor Tooley opened the public hearing. There were no questions or comments from the public, and the public hearing was closed.

Upon roll call, the Ordinance passed by a 5-0 vote.

9. ORD 2017-009

AN ORDINANCE AMENDING THE CITY'S CODE OF ORDINANCES BY AMENDING CHAPTER 13, "LAND DEVELOPMENT CODE," ARTICLE III, "ZONING REGULATIONS," DIVISION 2, "ZONING CLASSIFICATIONS AND GENERAL REQUIREMENTS," BY ENACTING A NEW SECTION 13-321, "MEDICAL MARIJUANA TREATMENT CENTERS," IN ORDER TO PROVIDE FOR MEDICAL MARIJUANA TREATMENT CENTERS TO LOCATE IN THE MEDICAL SERVICES OVERLAY AREA SUBJECT TO SPECIAL LAND USE APPROVAL; PROVIDING FOR APPLICATION REQUIREMENTS, DEVELOPMENT STANDARDS, AND PROCEDURES FOR DENIAL AND REVOCATION. (FIRST READING)

City Attorney Pyburn read the Ordinance title into the record.

MOTION: Welch/Rydell – To adopt Ordinance No. 2017-009.

City Attorney Pyburn summarized the discussions of the February 22, 2017, Commission Workshop and the March 8, 2017, Planning and Zoning Board Meeting. She highlighted the regulations contained in the proposed Ordinance. Discussion ensued regarding the locations of medical marijuana treatment centers and regulations for the cultivation of medical marijuana.

Mayor Tooley opened the public hearing. Todd Rogers, 5156 NW 74 Manor, Coconut Creek, stated his concern with the proximity of the Medical Services Overlay Area to Tradewinds Elementary School and commented that access to the facilities should be from US441 and not along the same frontage as the school. Ms. Rose clarified that the Planning and Zoning Board recommended approval of the Ordinance subject to limiting access to medical marijuana treatment centers to state and county arterial roadways.

Delilah Harden, 3781 Carambola Circle North, Coconut Creek, supported the idea of limiting access to the facilities to state and county roadways. There were no further questions or comments from the public, and the public hearing was closed.

AMENDMENT: Welch/Belvedere – To accept the Planning and Zoning Board's recommendation and amend the Ordinance to limit access to medical marijuana treatment centers to state and county arterial roadways.

Upon roll call, the Amendment failed by a 2-3 vote, with Commissioner Sarbone, Vice Mayor Rydell, and Mayor Tooley voting nay.

Upon roll call, the original motion to approve the Ordinance passed by a 4-1 vote, with Vice Mayor Rydell voting nay.
