RESOLUTION NO. 2018-036

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND ACADEMY BUS, LLC TO PROVIDE CHARTER BUS TRANSPORTATION SERVICES PURSUANT TO RFP NO. 12-13-17-10; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on November 19, 2017, the City issued Request for Proposals (RFP) No. 12-13-17-10 to contract with a qualified vendor to provide charter bus transportation services for the Parks and Recreation Department special events and summer youth recreation camp programs; and

WHEREAS, the services are required to transport children/adults to various sites throughout the state, but primarily within the boundaries of Broward, Palm Beach, and Miami-Dade County; and

WHEREAS, seven (7) electronic invitations were sent through the eBid System, and one (1) responsive submittal was received; and

WHEREAS, a selection committee consisting of Danielle DeBarros, Parks and Recreation Assistant Director; Lenore Thomas, Parks and Recreation Superintendent; and Enrique Castro, Parks and Recreation Supervisor, evaluated the proposal in accordance with the following criteria: (1) Operational Plan for the City, (2) Qualifications and Experience, (3) Resources and Availability, (4) Past Performance, and (5) Price; and

WHEREAS, based on the results of the reference surveys, proposed pricing, the vendor's proposal and the evaluations performed, the Selection Committee recommends awarding the contract to Academy Bus, LLC; and

WHEREAS, the initial contract period shall be for a two (2) year term, commencing on March 3, 2018. The City reserves the right to extend the contract for three (3)

additional one (1) year periods, providing each party agrees to the extension, all the terms, conditions, and specifications remain the same, and such extension is approved by the City; and

WHEREAS, the City Commission deems it to be in the best interest of the residents of the City of Coconut Creek to contract with Academy Bus, LLC to provide charter bus transportation services for the Parks and Recreation Department special events and summer youth recreation camp programs.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of this Resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the Agreement between the City of Coconut Creek and Academy Bus, LLC to provide charter bus transportation services pursuant to RFP No. 12-13-17-10.

Section 3: That the City Manager, or designee, is hereby authorized to execute the Agreement between the City of Coconut Creek and Academy Bus, LLC.

<u>Section 4</u>: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
