

**RESOLUTION NO. 2021-001**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A CONSULTING SERVICES WORK AUTHORIZATION WITH CRJ & ASSOCIATES, INC. TO PROVIDE SITE DESIGN SERVICES FOR TEMPORARY FIRE STATION NO. 113 IN THE AMOUNT OF \$70,150; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City has selected a site for placement of a temporary fire station trailer; and

**WHEREAS**, the construction of a driveway, parking lot, sidewalk, water and sewer connections, and related site amenities are necessary to accommodate the temporary station; and

**WHEREAS**, the City has an approved General Professional Engineering Services Contract with CRJ & Associates, Inc. to provide for the design of the aforementioned site needs; and

**WHEREAS**, CRJ & Associates, Inc. has submitted a proposal to provide the requested services in the amount of \$70,150; and

**WHEREAS**, staff recommends approval of a Consulting Services Work Authorization with CRJ & Associates to provide the aforementioned services; and

**WHEREAS**, the City Commission of the City of Coconut Creek finds and determines it to be in the best interest of the City and its residents to approve a Consulting Services Work Authorization with CRJ & Associates, Inc. to design the aforementioned site needs for Temporary Fire Station No. 113 in the amount of \$70,150.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:**

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

**Section 2:** That the City Commission has reviewed and hereby approves the attached Consulting Services Work Authorization between the City of Coconut Creek and CRJ & Associates, Inc. to provide the necessary design services for Temporary Fire Station No. 113 in the amount of \$70,150.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute said Consulting Services Work Authorization between the City of Coconut Creek and CRJ & Associates, Inc.

**Section 4:** That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
