RESOLUTION NO. 2019-062

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND ADVANCED ROOFING, INC. TO PROVIDE FOR ROOF REPLACEMENT AND INSTALLATION OF A SOLAR PHOTOVOLTAIC SYSTEM AT THE GOVERNMENT CENTER PURSUANT TO BID NO. 01-16-19-10; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission approved funding in the Capital Improvement Program for the Roof Replacement Program; and

WHEREAS, the funding for the Roof Replacement Program includes the replacement of the Government Center Roof; and

WHEREAS, the City issued Bid No. 01-16-19-10 entitled "Government Center Roof Replacement," through the e-bid system to contract with a qualified contractor to replace the Government Center roof, which includes the installation of a solar photovoltaic system; and

WHEREAS, the City received two (2) bid submittals for the aforementioned project, which were deemed to be responsive; and

WHEREAS, after careful review of both bid submittals, including references and past experience on projects of similar scope and value, staff recommends approval of an agreement with Advanced Roofing, Inc., the lowest responsible and responsive bidder, in the amount of \$2,504,819.58 for the purpose of replacing the Government Center roof and installing a solar photovoltaic system; and

WHEREAS, the City Commission finds and determines that it is in the best interest of the City to enter into an agreement with Advanced Roofing, Inc. for the purpose of

replacing the Government Center roof and installing a solar photovoltaic system in the amount of \$2,504,819.58.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and Advanced Roofing, Inc. for the purpose of replacing the Government Center roof and installing a solar photovoltaic system pursuant to Bid No. 01-16-19-10 in the amount of \$2,504,819.58.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the attached agreement between the City of Coconut Creek and Advanced Roofing, Inc. for the aforementioned purpose.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
