A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPOINTING ONE (1) REGULAR MEMBER AND ONE (1) ALTERNATE MEMBER TO THE COMMUNITY OUTREACH ADVISORY BOARD, TO FILL VACANCIES PURSUANT TO SECTION 2-193, "BOARD VACANCY" OF THE CITY'S CODE OF ORDINANCES FOR A TERM ENDING WITH THE NEXT APPOINTMENT IN 2021; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in accordance with Section 2-191(b) of the City's Code of Ordinances, the City Commission shall appoint board members at the second regularly-scheduled Commission meeting each April; and

WHEREAS, on July 23, 2020, in accordance with Section 2-266 of the City's Code of Ordinances, the City Commission appointed one (1) person to fill each position on the Community Outreach Advisory Board, and one (1) alternate member of the Board was selected by the Mayor; and

WHEREAS, a vacancy has occurred with Commissioner Sandra Welch's appointee and with the alternate member of the Board; and

WHEREAS, in accordance with Section 2-193 of the City's Code of Ordinances, vacancies of regular and/or alternate members of any board, commission or committee due to any reason whatsoever, shall be filled by the nomination of a person by the city commissioner who made the original nomination of the vacating member. Such nominations shall be approved by the majority of the City Commission in the same manner as for initial appointments.
