RESOLUTION NO. 2018-208

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE MANAGER, OR DESIGNEE, TO **EXECUTE** AGREEMENTS BETWEEN THE CITY OF COCONUT CREEK AND HINTERLAND GROUP, INC. (PRIMARY) AND SHENANDOAH GENERAL CONSTRUCTION COMPANY (SECONDARY), ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBITS "A" AND "B" RESPECTIVELY, TO PROVIDE REHABILITATION, REPAIRS. AND NEW CONSTRUCTION **SERVICES FOR STORMWATER** CONVEYANCE SYSTEMS PURSUANT TO BID NO. 06-27-PROVIDING **FOR SEVERABILITY:** 18-11: AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek (City) owns and maintains approximately 22 miles of stormwater pipes, 1,200 stormwater catch basins, concrete canal headwalls, swales, concrete curbs and gutters, and other stormwater-related infrastructure; and

WHEREAS, this infrastructure requires preventive and, at times, emergency repair work; and

WHEREAS, said infrastructure also requires expansion by installing new infrastructure as needed; and

WHEREAS, in addition to City staff work, contracted work is needed to meet current and future workload to provide for stormwater conveyance needs and flood control; and

WHEREAS, the City issued Bid No. 06-27-18-11 for said rehabilitation, repairs, and new construction services and received responsive bids from four (4) contractors:

1) Hinterland Group, Inc., 2) Shenandoah General Construction Company, 3) Southeastern Engineering Contractors, Inc., and 4) Madsen/Barr Corporation; and

WHEREAS, the Purchasing Division reviewed the bid responses for compliance and no issues were found; and

WHEREAS, the lowest responsive bidder was Hinterland Group, Inc., and the second lowest responsive bidder was Shenandoah General Construction Company; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to enter into agreements with Hinterland Group, Inc. as the primary contractor and Shenandoah General Construction Company as the secondary contractor to provide rehabilitation, repairs, and new construction services pursuant to Bid No. 06-27-18-11; and

WHEREAS, the agreements provide for a three (3) year term with two (2) one-year extensions with each contractor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of this Resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the Agreements between the City of Coconut Creek and Hinterland Group, Inc. and Shenandoah General Construction Company to provide rehabilitation, repairs, and new construction services pursuant to Bid No. 06-27-18-11.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the Agreements between the City of Coconut Creek and Hinterland Group, Inc. and Shenandoah General Construction Company.

Section 4: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
