RESOLUTION NO. 2006- 121

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AMENDING RESOLUTION NO. 2001-156, WHICH WAS AMENDED BY RESOLUTION NO. 2006-96, WHICH RESOLUTIONS ESTABLISHED THE SALARIES OF THE MAYOR AND COMMISSIONERS; BY ESTABLISHING ELIGIBILITY REQUIREMENTS FOR CONTINUING CITY GROUP INSURANCE ELIGIBILITY PURSUANT TO SECTION 112.0801, FLORIDA STATUTES; PROVIDING AN EFFECTIVE DATE

WHEREAS, Article III, Section 303 of the Charter of the City of Coconut Creek provides that the City Commission shall have the power to periodically establish the annual salaries of its members and to establish expenses and benefits for the City Commission; and

WHEREAS, the City Commission hereby finds and determines that an amendment to Section 24-24.2, Code of Ordinances, deleted the eligibility requirements for Elected Officials and Contractual Officials to remain on the City's group health insurance policy, pursuant to Section 112.0801, Florida Statutes; and

WHEREAS, the City Commission finds it necessary to establish eligibility requirements for Elected Officials and Contractual Officials;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That Resolution No. 2001-156 and Resolution No. 2006-96 which established the salaries, expense allowances and benefits of the Mayor and City Commission, are hereby amended as provided by the provisions of Sections 2, below.

<u>Section 2:</u> That the City Commission of the City of Coconut Creek, Florida, hereby establishes that Elected Officials and Contractual Officials who serve a

minimum of six (6) years of City service and attain a minimum age of forty-five (45) are also eligible for continuing City group insurance eligibility pursuant to Section 112.0801, Florida Statutes.

Section 3: That this Resolution shall take effect immediately upon its adoption.
