RESOLUTION NO. 2018-159

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE MAYOR AND THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE **FIRST AMENDMENT** TO INTERLOCAL AGREEMENT BETWEEN THE CITY OF MARGATE AND THE CITY OF COCONUT CREEK FOR TELETYPE SERVICES; PROVIDING FOR A FIVE (5) YEAR EXTENSION TO THE AGREEMENT AND ALLOWING MARGATE TO TERMINATE THE AGREEMENT IF MARGATE CONTRACTS WITH AN E-911 DISPATCH PROVIDER THAT INCLUDES TELETYPE SERVICES: PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on August 29, 2013, the City Commission approved the Participation Agreement by and between the City of Coconut Creek and Broward County, which authorizes the City's participation in the Consolidated Regional E-911 Communications System Agreement for a five (5) year term, renewable upon the agreement of the parties; and

WHEREAS, the Participation Agreement did not include teletype services required by the City's Police Department on a 24 hour basis; and

WHEREAS, the City of Margate has also approved an agreement with Broward County for Regional E-911 Communication Services, which does not include teletype services; and

WHEREAS, the City of Coconut Creek and the City of Margate entered into an Interlocal Agreement on November 20, 2013, that provided for the City of Coconut Creek to provide teletype services to the City of Margate; and

WHEREAS, the proposed Amendment No. 1 to the Interlocal Agreement provides for a five (5) year extension to the Agreement and allows Margate to terminate the Agreement with sixty (60) days' notice if Margate should contract with an E-911 dispatch provider that includes teletype services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves Amendment No. 1 to the Interlocal Agreement between the City of Margate and the City of Coconut Creek for teletype services.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute Amendment No. 1 to the Interlocal Agreement between the City of Margate and the City of Coconut Creek for teletype services.

<u>Section 4:</u> That if any clause, section, other part, or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall become effective immediately upon its adoption.
