A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE A CONTRACTOR SERVICES WORK AUTHORIZATION WITH P.L.A. ELECTRIC, INC. TO PURCHASE AND INSTALL TWO (2) NEW LIGHTED LAKE FOUNTAINS IN THE GOVERNMENT CENTER LAKES IN THE AMOUNT OF \$88,886.50; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Fiscal Year 2022 (FY22) Operating and Capital Improvement Budget, which was approved by the City of Coconut Creek Commission on September 23, 2021, through Ordinance No. 2021-024, included a project for lighted lake fountains as part of the Government Center Rehabilitation; and

WHEREAS, the proposed project includes the purchase and installation of two (2) programmable LED lighted lake fountains as well as installing the required electric power to operate the fountains; and

WHEREAS, these new fountains will provide a beautiful entryway feature for the Government Center and will enable City staff to program the lights to specific colors to celebrate designated themed months and holidays throughout the year; and

WHEREAS, P.L.A. Electric, Inc. was awarded a contract by the City as the primary vendor for electrical services through RFP No. 12-05-18-10 and has provided a proposal in the amount of \$88,886.50 for the purchase and installation of two (2) lighted lake fountains at the Government Center; and

WHEREAS, staff recommends approval of a contractor services work authorization with P.L.A. Electric, Inc. to provide the aforementioned services in the amount of \$88,886.50; and

WHEREAS, the City Commission of the City of Coconut Creek finds and determines it to be in the best interest of the City and its residents to approve a contractor

services work authorization with P.L.A. Electric, Inc. to provide the aforementioned electrical services for the Government Center Lighted Lake Fountains project in the amount of \$88,886.50.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached contractor services work authorization between the City of Coconut Creek and P.L.A. Electric, Inc. to provide the necessary electrical services for the Government Center Lighted Lake Fountains project in the amount of \$88,886.50.

Section 3: That the City Manager, or designee, is hereby authorized to execute the contractor services work authorization between the City of Coconut Creek and P.L.A. Electric, Inc. in the amount of \$88,886.50.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
