

RESOLUTION NO. 2016-106

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, APPOINTING AT LEAST EIGHT (8) BUT NO MORE THAN ELEVEN (11) MEMBERS TO THE AFFORDABLE HOUSING ADVISORY COMMITTEE PURSUANT TO SECTION 2-255 OF THE CITY OF COCONUT CREEK'S CODE OF ORDINANCES, AND IN ACCORDANCE WITH SECTION 420.9076, FLORIDA STATUTES, KNOWN AS THE STATE HOUSING INITIATIVES PARTNERSHIP ACT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in accordance with Section 2-255 of the City's Code of Ordinances, the City Commission shall appoint between eight (8) and eleven (11) members to the Affordable Housing Advisory Committee with varying qualifications pursuant to the requirements of Section 420.9076, Florida Statutes, also known as the State Housing Initiatives Partnership Act.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:


Section 1: That the City Commission hereby appoints the following individuals as members of the Affordable Housing Advisory Committee to fill the specific roles as delineated below, pursuant to Section 2-255, of the City's Code of Ordinances, for a three (3) year term:


