

RESOLUTION NO. 2016-264

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF COCONUT CREEK AND THE SCHOOL BOARD OF BROWARD COUNTY AUTHORIZING THE CITY TO DESIGN, CONSTRUCT, AND MAINTAIN LANDSCAPE IMPROVEMENTS ALONG THE COCONUT CREEK HIGH SCHOOL LAKE BANKS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the School Board of Broward County has been unable to fund the proper maintenance of the lake banks surrounding the lake adjacent to Coconut Creek High School; and

WHEREAS, the City has expressed a desire to undertake the design, construction, and maintenance of landscape improvements along the lake banks; and

WHEREAS, the School Board of Broward County has expressed their willingness to accommodate the City's desire contingent upon the City and School Board entering into a Maintenance Agreement; and

WHEREAS, under this Agreement the City will assume responsibility for the design, installation, and maintenance of landscape improvements to the aforementioned lake banks while the School Board will continue to be responsible for the maintenance of the lake itself and any current and future lake bank erosion issues; and

WHEREAS, staff recommends approval of the Agreement between the City of Coconut Creek and the School Board of Broward County authorizing the City to design, construct, and maintain landscape improvements along the Coconut Creek High School lake banks.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the City Commission has reviewed and hereby approves the attached Agreement between the City of Coconut Creek and the School Board of Broward County authorizing the City to design, construct, and maintain landscape improvements within the Coconut Creek High School lake banks.

Section 2: That the City Manager, or designee, is hereby authorized to execute said Agreement between the City of Coconut Creek and the School Board of Broward County.

Section 3: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 4: That this Resolution shall take effect immediately upon its adoption.
