\$10 per adult. Current sponsors include the Fellowship Recovery Community Organization, an anonymous donor, Laurie Shoats Counseling and Schelin Family Chiropractic. We are waiting for responses from other sponsors.

15. What benefits and positive effects will the City of Coconut Creek receive if a grant is awarded?

Tomorrow's Rainbow Rock Fest 2017 is good 'ole fashioned fun where adults and families alike can enjoy the charm of our beautiful City while enjoying great music and art in a natural farm setting. The music and art is homegrown featuring local talent exclusively. Coconut Creek is the home of the first and only stand-alone children's grief center in Broward County. Rock Fest showcases the long history between the City of Coconut Creek and Tomorrow's Rainbow in ensuring that no child ever has to grieve alone and that all children have an opportunity for a safe place to heal.

16. What percentage of the profits will go towards charity? What percentage will go towards administrative costs?

100% of the net proceeds from Rock Fest will go towards programming at Tomorrow's Rainbow. Although we never charge a fee for grief support groups, the cost of providing these services, free of charge on a miniature horse farm, is \$1,200 per year per child. The proceeds from Rock Fest will provide emotionally support for more than 7 grieving children.
