RESOLUTION NO. 2017-137

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED WORK AUTHORIZATION FOR LANDSCAPE ARCHITECTURAL DESIGN SERVICES TO BE PROVIDED BY KEITH AND SCHNARS, P.A. RELATED TO LANDSCAPE AND IRRIGATION IMPROVEMENTS ALONG THE LAKE BANK ADJACENT TO COCONUT CREEK HIGH SCHOOL (CCHS) AND COUGAR TRAIL; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the lake bank adjacent to Coconut Creek High School (CCHS) and the swale area across from CCHS along Cougar Trail are in need of improvements; and

WHEREAS, the City Commission of the City of Coconut Creek approved funding to improve these areas; and

WHEREAS, landscape architectural services are necessary to prepare the plans and specifications for these improvements; and

WHEREAS, Keith and Schnars, P.A. was selected as a qualified consultant pursuant to RFQ No. 08-24-16-11 Architecture, Landscape Architectural and Urban Design Services; and

WHEREAS, Keith and Schnars, P.A. proposes to provide landscape architectural design services for improvements to this area in the amount of \$39,930; and

WHEREAS, the Public Works Department reviewed the fee proposal, considers the fees to be fair and reasonable, and recommends approval of the Work Authorization attached hereto; and

WHEREAS, the City Commission of the City of Coconut Creek deems it to be in the best interest of the residents to approve the aforementioned Work Authorization with Keith and Schnars, P.A. for the purpose of providing landscape architectural services for improvements along the CCHS lake bank and Cougar Trail swale area.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are incorporated herein and made a specific part of this Resolution.

<u>Section 2</u>: That the City Commission has reviewed and hereby approves the attached Work Authorization with Keith and Schnars, P.A. for landscape architectural services related to the Coconut Creek High School lake bank and Cougar Trail swale.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute the attached Work Authorization between the City of Coconut Creek and Keith and Schnars, P.A.

Section 4: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

<u>Section 5</u>: That this Resolution shall be in full force and effect immediately upon its adoption.
