CITY MANAGER ANNUAL PERFORMANCE REVIEW

Commissioner Belvedere commended City Manager Blasi and her staff for their hard work during Hurricane Irma. She commented that she was responsive, thorough, and had a positive attitude. She rated her a five throughout the evaluation form.

Commissioner Welch spoke about City Manager Blasi's responsible fiscal management and leadership abilities that encourage teamwork among City staff. She commended her for a positive working relationship with residents and ensuring the City's financial and economic stability. She made the following recommendations:

- Assistant City Manager Karen Brooks be included on their communications;
- Provide periodic updates on MainStreet and Hillsboro Boulevard redevelopment activity; and
- Host a Lunch Bunch meeting before the start of the school year.

Commissioner Sarbone noted that he provides regular feedback to City Manager Blasi and said overall she does a great job. He commented that her leadership attracts quality staff to the City. He was in favor of the maximum pay increase and recommended modifying City Manager Blasi's contract from a lump sum payment for the increase. Discussion ensued.

Vice Mayor Rydell noted that he rated City Manager Blasi a five in most areas and requested that she provide an update from the weekly staff meetings with Department Directors. He commended her for improved communication with the Commission during the year and recommended improving communication with Broward County. He stated that City Manager Blasi is an advocate for the City. He commended her for her support staff and fiscal expertise. He was in favor a five percent bonus.

Mayor Tooley commented on City Manager Blasi's foresight and was pleased with her leadership.
