

RESOLUTION NO. 2017-306

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE THE FIRST AMENDMENT TO THE SCHOOL RESOURCE OFFICER (SRO) AGREEMENT BETWEEN THE SCHOOL BOARD OF BROWARD COUNTY AND THE CITY OF COCONUT CREEK TO PROVIDE FUNDING FOR ONE (1) ADDITIONAL SRO FOR A PERIOD COMMENCING ON NOVEMBER 1, 2017, AND ENDING ON JUNE 7, 2018; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the School Board of Broward County has established a School Resource Officer (SRO) Program pursuant to Section 230.2319, Florida Statutes; and

WHEREAS, the City of Coconut Creek and the School Board of Broward County agree that the SRO Program provides benefits to the school administration, students, and the community as a whole; and

WHEREAS, the City entered into an agreement with the School Board of Broward County for eight (8) SROs dated July 25, 2017 ("Agreement"); and

WHEREAS, the City requested another SRO for the Dave Thomas Education Center-West Campus, which the School Board of Broward County has agreed to fund; and

WHEREAS, the proposed First Amendment to the Agreement provides for nine (9) SROs, including one (1) to be assigned to the Dave Thomas Education Center-West Campus; and

WHEREAS, the City and the School Board of Broward County have agreed that the School Board will provide \$41,626.80 to the City per month commencing on November 1, 2017, and ending June 7, 2018, for a total of \$402,392.40. However, the City shall make appropriate pro rata reductions in the amount invoiced during any month in which emergency circumstances reduce the amount of SRO services provided

by the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2: That the City Commission has reviewed and hereby approves the First Amendment to the School Resource Officer Agreement between the School Board of Broward County and the City of Coconut Creek.

Section 3: That the Mayor is hereby authorized to execute the First Amendment to the School Resource Officer Agreement between the School Board of Broward County and the City of Coconut Creek.

Section 4: That if any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
