# INPUT FROM RESIDENTS OF COCONUT CREEK

Maria Avolio, 4131 NW 9 Street, Coconut Creek, spoke about a permit she pulled to have a picnic in the park for Easter and inquired why alcohol is no longer allowed with the permit. Parks and Recreation Director Wayne Tobey explained that there were two parks in the City that allowed alcohol with the permit: Cypress Park and Sabal Pines Park.

#### CITY MANAGER REPORT

Assistant City Manager Brooks announced that it was Hurricane Preparedness Week and encouraged everyone to prepare for the upcoming Hurricane Season, which begins on June 1.

# **CITY ATTORNEY REPORT**

City Attorney Pyburn had no report.

## **COMMISSION COMMUNICATIONS**

Commissioner Belvedere attended the Metropolitan Planning Organization (MPO) meeting where there was discussion regarding the future implementation of a mileage tax in addition to the gas tax to account for the increase in hybrid vehicles. She reported that the federal Community Development Block Grant (CDBG) Program would be funded next fiscal year and that National Walk to School Day would be celebrated on October 4, 2017. She spoke about a resolution passed by the City of North Lauderdale to modify school zones with solar-powered, yellow, flashing lights.

Commissioner Welch commended the City Clerk Department staff for their professionalism and customer service. She thanked Parks and Recreation Director Wayne Tobey for offering additional yoga classes at the recreational facilities. She commented on the Fire Department's ISO 1 rating. She attended a presentation by the Police Department at Lyons Creek Middle School regarding synthetic drugs and thanked Police Chief Arenal and Sergeant Brandi DelVecchio for their attendance. She wished everyone a happy Mother's Day.

Commissioner Sarbone mentioned he was pleased with the median improvements along Hillsboro Boulevard that were completed with grant funds.

Vice Mayor Rydell attended a parent resource fair at Coconut Creek High School. He asked for and received consensus for staff to research a modification to the City's Code to require that all proposed site plans be presented to the City Commission for approval. Commissioner Sarbone suggested that staff also research the City of Fort Lauderdale's professional requirements for Planning and Zoning Board members. Consensus was given to have a workshop on staff's research for a modification to the City's Code related to site plan approvals and professional requirements for Planning and Zoning Board members. Mayor Tooley requested that the workshop be held on a date separate from a commission meeting to allow ample time for discussion.

Mayor Tooley thanked Vice Mayor Rydell for attending the events she was unable to attend during the week. She met with former Parks and Recreation Director Linda Wiederspan, who retired last year. Ms. Wiederspan plans to attend the City's 50<sup>th</sup> Anniversary Gala.

The Commission gave staff direction to amend Section 5-8(c) of the Ordinance for second reading to note that the civil violation is \$500.00 per animal, per violation.

Maria Avolio, 4131 NW 9 Street, Coconut Creek, asked where she can release wild animals that she traps on her property. Mr. Berkman stated that State Statute does not permit the release of wild animals on any property without the property owner's consent.

Sustainable Development Director Sheila Rose presented the items and noted that the Applicant had provided additional information regarding Green Globe certification as an alternative solution to LEED certification. Ms. Rose answered questions regarding drainage surrounding the site.

Attorney Dan Taylor of Tripp Scott Law Firm, on behalf of the Applicant, Gunther Motor Company, introduced himself, Jay Gunther, and Jeffrey Peal of Stiles Architectural Group. Mr. Peal began a *PowerPoint* presentation and discussed the differences between the Green Globe and LEED certification processes. Discussion ensued.
