6. Brief Description of Event/Approximate Number of Attendees: iLUMA is an arts integration residency pairing music, visual art, and literature with reading comprehension. Participants ages 4-11 and seniors use keywords to draw and color answers to reading comprehension questions in each month's storybook. For each story, students will receive a storybook that contains seven panels with the written story and incomplete illustrations in each panel. For each panel, a narrator will read the narration then ask students to complete the drawing based on information in the story. Musicians from the SFCE play music from the stage version of the fairy tale as the children complete their drawings. We will be using fairy tales from the around the world to add a literary and cultural component to the project. The stories are: Little Mermaid (Czech Republic), A Christmas Carol (England), Peer Gynt (Norway), Treemonisha (USA) and Snow White (Germany). Before each story begins, the narrator teaches participants how to say yes and no in the language of the culture and gives cultural information such as location, climate, favorite foods, and schools. Each storybook is collected at the end of each session and independently scored by two or more teaching artists. Scores are entered in to a spreadsheet to track improvement. Storybooks are returned to students at the end of the residency. The objectives of the project are: to use keywords to promote reading comprehension, to expose participants to classical music, literature, and world cultures, and to encourage a love of reading. We anticipate 125 attendees per session for a total attendance of 625.

We are requesting \$2000 in matching funds from the City of Coconut Creek. \$620.00 of funds will go towards ink to print advertising of the program to residents of Coconut Creek and the surrounding areas as well as directly to preschools with VPK programs and to print the storybooks. \$1380 will pay part of the cost of arranging the musical scores to fit our ensemble for Little Mermaid, Snow White, A Christmas Carol, Treemonisha, and Peer Gynt.

List other funding/grants that will go toward the event (i.e. cash, in-kind services, donations, grants, etc.) We have secured a grant the amount of \$1620 from the Broward Cultural Division for this location. We are seeking the remaining matching funds in the amount of \$2000 to cover the cost of implementing the program at the North Regional/Broward College Library in Coconut Creek. The library is donating the use of the auditorium, piano, microphone and projector for this program at no additional cost. The library is also providing marketing for the program including adding this to their event list on the website, posting flyers about the program in the library and posting information on external sites like South Florida Parenting and 4FunKids.

17. What benefits and positive effects will the City of Coconut Creek receive if a grant is awarded? We completed a five month residency in Coconut Creek of this program in April 2018. All participants in this residency increased their reading comprehension and fine motor skills score over the course of the residency. The VPK instructors who attended the program were very enthusiastic about the program and have signed on to participate again this season and we have received calls from other schools who wish to participate as well. Last year's teachers were also pleased with the improvement in the attention span and behavior of their students by the end of the residency and found the cultural information about the country in which the story was set to be informative and interesting for their students. This season we are opening the program to third to fifth grade students with disabilities.




