RESOLUTION NO. 2018-136

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE USE OF FEDERAL LAW ENFORCEMENT TRUST FUNDS IN THE AMOUNT OF \$485,430 FOR THE PURCHASE OF RIFLE PLATES, ACTIVE SHOOTER LEG RIGS, MOTOROLA SOFTWARE UPDATE TO P25 RADIO SYSTEM, PORTABLE AND MOBILE RADIOS, DELL LAPTOPS AND TABLETS, POLICE VEHICLES, K-9 FIELD FENCE, SALARIES FOR SCHOOL RESOURCE OFFICERS FOR FISCAL YEAR 2019; AUTHORIZING THE USE OF LOCAL LAW ENFORCEMENT TRUST FUNDS IN THE AMOUNT OF \$6,000 TO PROVIDE A DONATION TO THE POLICE EXPLORER POST; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek has established a Federal Law Enforcement Trust Fund for receipt and disbursement of forfeiture monies, pursuant to the Federal Department of Justice Agreement, and a Local Law Enforcement Trust Fund for receipt and disbursement of forfeiture monies, pursuant to Section 932.7055, Florida Statues; and

WHEREAS, the Chief of Police has requested that the City Commission make an appropriation from said funds; and

WHEREAS, the funds from the above request will be utilized for law enforcement purposes, including the purchase of rifle plates, active shooter leg rigs, Motorola software update(s), portable and mobile radios, dell laptops and tablets, police vehicles, K-9 field fence, salaries for School Resource Officers for Fiscal Year 2019, and a donation to the Police Explorers; and this appropriation of funds complies with the requirements of the State of Florida Forfeiture Guidelines and/or the Department of Justice/Treasure Forfeiture Guidelines.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and

confirmed as being true and correct and are hereby made a specific part of this Resolution.

<u>Section 2:</u> That the City Commission hereby approves the appropriation of Four Hundred Eighty-Five Thousand, Four Hundred Thirty Dollars (\$485,430) from the Federal Law Enforcement Trust Fund for rifle plates, active shooter leg rigs, Motorola software update, portable and mobile radios, dell laptops and tablets, police vehicles, K-9 field fence, salaries for School Resource Officers for Fiscal Year 2019, and Six Thousand Dollars (\$6,000) from the Local Law Enforcement Trust Fund as a donation to the Police Explorers.

Section 3: That the City Commission hereby authorizes the City Manager, or designee, to proceed with the above expenditure from forfeiture funds.

Section 4: That if any clause, section, other part or application of this Resolution is held by any court or competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this Resolution.

Section 5: That this Resolution shall be in full force and effect immediately upon its adoption.
