ORDINANCE NO. 2013- 023

AN ORDINANCE OF THE CITY OF COCONUT CREEK, FLORIDA, REPEALING IN ITS ENTIRETY ORDINANCE NO. 2008-040. PROVIDING FOR A REVISION OF THE BOUNDARIES OF COMMISSION VOTING DISTRICTS; THE **RECOMMENDATION** OF ACCEPTING REDISTRICTING BOARD, WHICH PROVIDES FOR A REVISION OF THE EXISTING LEGAL BOUNDARIES FOR THE FIVE AT LARGE COMMISSION VOTING DISTRICTS, AS MORE FULLY DESCRIBED IN THE MAP AND LEGAL DESCRIPTIONS, LABELED "A" THROUGH "E". RESPECTIVELY, ATTACHED HERETO AND MADE A PART HEREOF; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE

WHEREAS, the population of Coconut Creek has increased since 2008 when Ordinance No. 2008-040 was adopted establishing the boundaries of City Commission voting districts, thus resulting in imbalanced population variances among the City Commission voting districts; and

WHEREAS, Section 908 of the City Charter authorizes the City Commission to enact an Ordinance providing for revision of Commission voting districts to ensure compliance with the mandate to balance population variances reasonably among all districts; and

WHEREAS, the City Commission hereby accepts the recommendation of the Redistricting Board to revise the legal boundaries of the existing Commission voting districts as shown on the map attached described as Alternative 3.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That Ordinance No. 2008-040 is hereby repealed in its entirety.

<u>Section 2:</u> That the five at-large Commission voting districts are hereby revised as set forth in the legal descriptions dated October 30, 2013 and labeled "A" through "E", and the map labeled Alternative 3, attached hereto and made a part hereof

as follows:

Revised District A	shall become	Voting District A
Revised District B	shall become	Voting District B
Revised District C	shall become	Voting District C
Revised District D	shall become	Voting District D
Revised District E	shall become	Voting District E

<u>Section 3:</u> That the revised Commission voting districts shall be effective immediately upon passage of this Ordinance, and said revised Commission voting districts shall be utilized for the next City election.

<u>Section 4</u>: That in the event any provision or application of this Ordinance shall be held to be invalid, it is the legislative intent that the other provisions and applications hereof shall not be hereby affected.

Section 5: That all Ordinances or parts of Ordinances in conflict herewith are, to the extent of said conflict, hereby repealed.

<u>Section 6</u>: That this Ordinance shall take effect immediately upon its passage and adoption.




