## **RESOLUTION NO. 2019-243**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENT FOR THE CONSTRUCTION SERVICES TO BE PROVIDED BY R.P. UTILITY & EXCAVATION CORP. TO CONSTRUCT A WASTEWATER TRANSMISSION LINE ON COPANS ROAD AND LYONS ROAD AND RELINE PART OF THE EXISTING FORCEMAIN ON COPANS ROAD PURSUANT TO BID NO. 09-12-19-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has a wastewater disposal agreement with Broward County dated May 23, 1999 ("Large User Wastewater Agreement"); and

**WHEREAS**, said Large User Wastewater Agreement states that the City owns the wastewater transmission main (forcemain) along Copans Road to the Broward County Wastewater Treatment Plant; and

**WHEREAS,** said forcemain serves City residents south of Sample Road, including the Township and Wynmoor communities; and

**WHEREAS,** said forcemain has been in service for 40 years and is approaching the end of its lifespan; and

**WHEREAS**, the existing forcemain is currently the only forcemain conveying this portion of wastewater to the treatment plant and, therefore, cannot be taken out of service for repair in case of an emergency; and

WHEREAS, the City completed the design using the City's Engineering consultant, R.J. Behar & Company, Inc., to construct a forcemain along Copans Road and Lyons Road, which will connect to the Broward County forcemain on Sample Road, and to reline the existing forcemain along Copans Road up to the Turnpike overpass; and

**WHEREAS**, these improvements will provide redundancy and wastewater flowage flexibility to the system south of Sample Road and allow system maintenance without interruption of services to the City's residents and businesses; and

WHEREAS, the City received bids from four contractors pursuant to Bid No. 09-12-19-11 for this project: 1) R.P. Utility & Excavation Corp., 2) Metro Equipment Service, Inc., 3) Murphy Pipeline Contractors, Inc., and 4) David Mancini & Sons, Inc.; and

**WHEREAS**, the Purchasing Division reviewed the bid responses for compliance and no issues were found; and

WHEREAS, the lowest responsive bidder was found to be R.P. Utility & Excavation Corp.; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with R.P. Utility & Excavation Corp. for the construction of the wastewater transmission line on Lyons Road and rehabilitation of the existing forcemain at Copans Road in the amount of \$2,874,998.00, pursuant to Bid No. 9-12-19-11.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

<u>Section 1:</u> That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution. All exhibits attached hereto are incorporated herein and made a specific part of this resolution.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the attached agreement between the City of Coconut Creek and R.P. Utility & Excavation Corp. for the Copans Road and Lyons Road Wastewater Transmission System project.

**Section 3:** That the City Manager, or designee, is hereby authorized to execute said agreement between the City of Coconut Creek and R.P. Utility & Excavation Corp.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 5:** That this resolution shall be in full force and effect immediately upon its adoption.
