**TITLE:**

A RESOLUTION RELATING TO THE PROVISION OF FIRE PROTECTION SERVICES, FACILITIES, AND PROGRAMS IN THE CITY; ESTABLISHING THE RATE OF ASSESSMENT; IMPOSING FIRE PROTECTION SERVICE ASSESSMENTS AGAINST ASSESSED PROPERTY LOCATED WITHIN THE CITY; AND APPROVING THE ASSESSMENT ROLL. (PUBLIC HEARING)

**BACKGROUND:**

The Fire Protection Service Assessment Ordinance (Ordinance No. 2000-21) provides for an annual assessment against certain properties for fire protection services, facilities, and programs.

**DISCUSSION:**

This Resolution sets the fire assessment rates for the fiscal year beginning October 1, 2016, through September 30, 2017, to recover 100% of the cost of providing fire protection services. It imposes the assessment against certain properties within the City of Coconut Creek and approves the assessment roll provided by the Property Appraiser's Office. No rate changes are proposed. Please see Exhibit A for a listing of assessment rates by property type.

**RECOMMENDATION:** Staff recommends approval of this Resolution.
