**TITLE:**

A RESOLUTION AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE REVOCABLE LICENSE AGREEMENTS WITH BROWARD COUNTY AUTHORIZING THE CITY TO INSTALL CITY ENTRANCEWAY SIGNS WITHIN MEDIAN RIGHTS-OF-WAY ON WILES ROAD, LYONS ROAD, COPANS ROAD, AND COCONUT CREEK PARKWAY.

**BACKGROUND:**

The City of Coconut Creek has established a Capital Improvement Program (CIP) to replace all City entranceway signs located within the medians. Some of these proposed new sign locations, including Wiles Road, Lyons Road, Copans Road, and Coconut Creek Parkway, are within Broward County Rights-of-Way. Broward County requires that Revocable License Agreements (RLA) be signed prior to authorizing any signs to be installed within their Rights-of-Way.

**DISCUSSION:**

Under these agreements, the City will assume responsibility for the maintenance of the signs and associated landscaping within the license areas. The agreements will remain in effect in perpetuity or until termination by Broward County.
