# AGENDA ITEM REPORT

### TITLE:

A RESOLUTION AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE ATTACHED AGREEMENTS WITH THE STATE OF FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION FOR THE FLORIDA RECREATION DEVELOPMENT ASSISTANCE (FRDAP) PROGRAM GRANTS FOR WINDMILL PARK.

#### BACKGROUND:

The State of Florida Department of Environmental Protection offers assistance on a competitive basis to communities that are improving recreational facilities. The City applied for and has been awarded two grants totaling \$250,000 for the Windmill Park Improvements Project.

#### DISCUSSION:

The Windmill Park Improvements Project has been approved by the City Commission within the Capital Improvement Projects (CIP) budget. These two grants, totaling \$250,000, have already been programmed into the CIP budget, helping to offset some of the construction costs associated with this project.

#### **RECOMMENDATION:**

Staff recommends approval of this Resolution.
