## AGENDA ITEM REPORT

### TITLE:

A RESOLUTION AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE SCHOOL RESOURCE OFFICER (SRO) AGREEMENT WITH NORTH BROWARD PREPARATORY SCHOOL FOR A PERIOD COMMENCING OCTOBER 1, 2018, AND ENDING SEPTEMBER 30, 2019.

### BACKGROUND:

North Broward Preparatory School has requested the services of a Coconut Creek School Resource Officer (SRO).

### DISCUSSION:

The SRO Program is a great benefit to school administration, students, and the community as a whole. The attached SRO Agreement provides for one (1) SRO at North Broward Preparatory School for a twelve (12) month period, beginning October 1, 2018, and ending September 30, 2019. The City will receive \$11,416.66 per month for one (1) SRO for twelve (12) months during the term of the Agreement, for a total of \$137,000. The Agreement provides for up to three (3) one-year extensions.
