AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A FLEET SERVICES BUILDING LEASE AGREEMENT WITH VECTOR FLEET MANAGEMENT, LLC TO PROVIDE FOR THE LEASE OF A PORTION OF THE CITY'S FLEET SERVICES BUILDING. (SECOND READING) (PUBLIC HEARING)

BACKGROUND:

This item was approved on First Reading at the September 27, 2018, City Commission Meeting.

The City of Coconut Creek is awarding a contract to Vector Fleet Management, LLC for the purpose of providing fleet management and equipment maintenance services pursuant to RFP No. 06-27-18-10.

DISCUSSION:

Vector Fleet Management, LLC will be performing the aforementioned services utilizing a portion of the City's Fleet Services Building located directly behind the Public Works/EOC Building. This lease is for the portion of the Fleet Services Building to be occupied and utilized by the Contractor and runs concurrent with the above mentioned contract.
