TITLE:

A RESOLUTION APPOINTING FIVE (5) REGULAR MEMBERS AND ONE (1) ALTERNATE MEMBER TO THE PUBLIC SAFETY ADVISORY BOARD FOR A ONE-YEAR TERM.

BACKGROUND:

On March 14, 2019, the City Commission adopted Ordinance No. 2019-006, which established a Public Safety Advisory Board to serve in an advisory capacity to the City Commission in matters relating to public safety that may impact the community.

In accordance with Section 2-270 of the Code of Ordinances, each Commissioner shall nominate one person to fill a position of membership on the Public Safety Advisory Board. This appointment shall be for a one-year term that will expire on the date of the second regularly-scheduled Commission meeting in April 2020. The Mayor will nominate one person to fill the alternate position.
