### TITLE:

A RESOLUTION APPROVING THE SETTLEMENT AGREEMENT AND RELEASE REGARDING DISTRIBUTION OF CERTAIN SETTLEMENT FUNDS FROM ALLERGAN FINANCE, LLC (F/K/A ACTAVIS, INC., WHICH IN TURN, WAS WATSON PHARMACEUTICALS, INC.), ALLERGAN SALES, LLC, ALLERGAN USA, INC. AND ALLERGAN LIMITED (F/K/A ALLERGAN PLC, WHICH IN TURN, WAS F/K/A ACTAVIS PLC) AS PART OF THE FLORIDA ATTORNEY GENERAL ACTION REGARDING THE OPIOID LITIGATION; AUTHORIZING THE MAYOR TO EXECUTE ALL NECESSARY AGREEMENTS.

### **BACKGROUND:**

The City of Coconut Creek is a litigating participant in the action that the State of Florida has filed pending in Pasco County, Florida, and a number of Florida Cities and Counties have also filed an action *In re: National Prescription Opiate Litigation*, MDL No. 2804 (N.D. Ohio) (the "Opioid Litigation"). The State of Florida and lawyers representing certain various local governments involved in the Florida Attorney General Action proposed a unified plan for the allocation and use of prospective settlement dollars from opioid related litigation in or around April 2021 (the "Florida Plan"). That was for a settlement with the big three (3) distributors and Johnson and Johnson. This proposed Settlement Agreement was offered by Allergan Finance, LLC (f/k/a Actavis, Inc., which in turn, was Watson Pharmaceuticals, Inc), Allergan Sales, LLC, Allergan USA, Inc. and Allergan

Limited (f/k/a Allergan PLC, which in turn, was f/k/a Actavis PLC) ("ALLERGAN") and provides for a payment of One Hundred Thirty-Four Million, Two Hundred Thousand Dollars (\$134,200,000) for all participants based on the same methodology for distribution of funds as provided in the Florida Plan, which the City approved in 2021, to be paid out over 18 years ("ALLERGAN Settlement"). The monies ultimately received from the Settlement can only be used for the following Core Strategies related to abating the harm: a. Naloxone or other FDA-approved drug to reverse opioid overdoses; b. Medication-Assisted Treatment ("MAT") Distribution and other opioid-related treatment; c. Pregnant and Postpartum Women; d. Expanding Treatment for Neonatal Abstinence Syndrome; e. Expansion of Warm Hand-Off Programs and Recovery Services; f. Treatment for Incarcerated Population; g. Prevention Programs; h. Expanding Syringe Service Programs; and i. Evidence-based data collection and research analyzing the effectiveness of the abatement strategies within the State.

#### **DISCUSSION:**

The proposed settlement allocation to the City of Coconut Creek is \$18,000.00 to be paid out over 18 years, beginning once the Court enters the Consent Judgement regarding the settlement.
