RESOLUTION NO. 2023-047

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, SUPPORTING AN APPLICATION FOR FUNDING FROM THE MUNICIPAL CAPITAL PROJECTS PROGRAM, FUNDED BY THE TRANSPORTATION SURTAX, FOR THE DESIGN AND CONSTRUCTION OF THE SOUTH CREEK NEIGHBORHOOD IMPROVEMENT PROJECT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek's South Creek neighborhood roadway infrastructure has been impacted by traffic-induced fatigue, and the City is seeking to commit to the design and construction for the South Creek Neighborhood Improvement Project; and

WHEREAS, the design scope includes traffic calming features, milling and resurfacing of designated local streets, roadway pavement markings and signage, accessible sidewalk and curbing improvements, widening of existing bridges, drainage improvements, and other measures to improve the mobility infrastructure, as well as the aesthetics and functionality of the various right-of-way features; and

WHEREAS, the City is submitting an application for funding from the Municipal Capital Projects Program (funded by the Transportation Surtax) for design and construction of the South Creek Neighborhood Improvement Project for select City-owned local roadways located between Coconut Creek Parkway and West Atlantic Boulevard and between Lyons Road and Florida's Turnpike; and

WHEREAS, the City is required to provide a resolution, expressing support for the South Creek Neighborhood Improvement Project, and commit to funding the maintenance of the improvements to be constructed within the City of Coconut Creek's right-of-way; and

WHEREAS, the City Commission deems it to be in the best interest of the City and its residents to express its support for the use of Broward County Transportation Surtax

Funds for the project and to commit to fund the maintenance of the improvements to be constructed within the City of Coconut Creek's right-of-way.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

<u>Section 2:</u> That the City supports the South Creek Neighborhood Improvement Project and commits to fund the perpetual maintenance of the improvements to be constructed within the City of Coconut Creek's right-of-way.

<u>Section 3:</u> That the City Clerk is hereby directed to provide a copy of this resolution of support to the Broward Metropolitan Planning Organization for the City's application for funding request for the South Creek Neighborhood Improvement Project.

<u>Section 4:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
