During his career, K-9 Noble has located and apprehended numerous felony suspects. K-9 Noble also became the USPCA Region 1 Top Dog Champion at the 2024 USPCA Field Trials. He also secured numerous national accolades over his career including 2nd place in obedience, 5th place in apprehension, and 9th place overall in the National Field Trials.

Due to the age of K-9 Noble; his handler being promoted to the rank of sergeant; and the fact that he has already been acclimated to the family and household of his handler, Sergeant Amanda Cummings; I recommend the City sell K-9 Noble to Sergeant Cummings for \$10.00 (ten dollars and no cents) as is customary in the law enforcement profession.

K-9 Noble's retirement will be effective on January 9, 2025.
