A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE AN AGREEMENT WITH VISUALSCAPE, INC. FOR LYONS ROAD MEDIAN IMPROVEMENTS PURSUANT TO IFB NO. 05-16-23-11; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Lyons Road medians from Coconut Creek Parkway to Atlantic Boulevard remain unimproved and are in need of improvements; and

WHEREAS, on April 9, 2023, the City issued Invitation for Bids (IFB) No. 05-16-23-11 to contract with licensed contractors to enhance these Lyons Road medians; and

WHEREAS, enhancements will include new pavers, irrigation, sod, shrubs and trees; and

WHEREAS, the City issued five hundred twenty six (526) electronic invitations for bids for the Lyons Road Median Improvements project; and

WHEREAS, five (5) responsive submittals were received from the following companies: 1) VisualScape, Inc. (\$738,154.83); 2) MBR Construction, Inc. (\$910,532.20); 3) Superior Landscaping & Lawn Service, Inc. (\$979,928.00); 4) Rosso Site Development, Inc. (\$1,121,146.87); and 5) Arazoza Brothers Corp. (\$1,191,047.75); and

WHEREAS, the Procurement Division reviewed the bid responses for compliance, and no issues were found; and

WHEREAS, staff recommends approval of this agreement with VisualScape, Inc., the lowest, responsive bidder, for the Lyons Road Median Improvements project; and

WHEREAS, the City Commission finds and determines it to be in the best interest of the City to enter into an agreement with VisualScape, Inc. for the Lyons Road Median

Improvements project pursuant to IFB No. 05-16-23-11.

<u>Section 2:</u> That the City Commission has reviewed and hereby approves the agreement between the City of Coconut Creek and VisualScape, Inc., attached hereto and made a part hereof as Exhibit "A," to enhance the Lyons Road medians between Coconut Creek Parkway and Atlantic Boulevard pursuant to IFB No. 05-16-23-11 for \$738,154.83.

<u>Section 3:</u> That the City Manager, or designee, is hereby authorized to execute said agreement between the City of Coconut Creek and VisualScape, Inc. and any change orders in accordance with the Purchasing Policies & Procedures Manual.

Section 4: That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

Section 5: That this resolution shall be in full force and effect immediately upon its adoption.
