

**AMENDMENT NO. 1 TO THE AGREEMENT BETWEEN THE CITY AND
HUMAN SERVICES NETWORK, INC. D/B/A MEALS ON WHEELS SOUTH FLORIDA
FOR MEAL ASSISTANCE SERVICES RELATED TO THE COVID-19 EMERGENCY
TO AID THE CITY'S COMMUNITY**

This Amendment No. 1 to the Agreement between the City and Human Services Network, Inc. D/B/A Meals on Wheels South Florida for Meal Assistance Services related to the Covid-19 Emergency to aid the City's community dated April 14, 2023 ("Agreement") is made this 25th day of January, 2024, by and between the City of Coconut Creek, Florida, (the "City"), and Human Services Network, Inc. D/B/A Meals on Wheels South Florida (the "Contractor OR Vendor") both of whom agree as follows:

WITNESSETH:

WHEREAS, the parties desire to amend the Agreement between the City and Human Services Network, Inc. D/B/A Meals on Wheels South Florida for meal assistance services related to the Covid-19 Emergency to aid the City's community dated April 14, 2023 to allow for the ability to increase the number of meals from two (2) meals per day five (5) times per week (10 meals total per week), to two (2) meals per day for up to seven (7) times per week (for up to 14 meals total per week), as needed. Per Meals on Wheels, if a client is considered high risk by their nutritionist, they serve them up to seven (7) days of the week, and this amendment will provide reimbursement for the additional meals as needed.

NOW, THEREFORE, based on the promises and covenants herein contained, the parties agree as follows:

1. The recitations referred to above are hereby incorporated herein.
2. The parties desire to amend Exhibits 1 and 2 to the Agreement to provide for the increased number of meals per week as attached to this Amendment No.1.
3. All other terms and conditions of the Agreement shall remain in full force and effect and are incorporated herein.
