## **RESOLUTION NO. 2025-184**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, ACCEPTING THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) FISCAL YEAR 2026 (FY26) OCCUPANT PROTECTION AND CHILD PASSENGER SAFETY GRANT IN THE AMOUNT OF \$40,000; AUTHORIZING THE CITY DESIGNEE. MANAGER. OR EXECUTE THE TO ATTACHED GRANT BETWEEN FDOT AND THE CITY OF COCONUT CREEK FOR SEAT BELT AND CHILD **PASSENGER** SAFETY **EDUCATION** AND **ENFORCEMENT: PROVIDING FOR SEVERABILITY: AND** PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Coconut Creek Police Department applied for the FDOT FY26 Occupant Protection and Child Passenger Safety Grant and was one of the organizations selected by FDOT to receive forty thousand dollars (\$40,000) in funding; and

WHEREAS, the grant will offset expenses for overtime, allowing the Coconut Creek Police Department to participate in the "Click It or Ticket" enforcement campaign, as well as educating the public on the importance of proper seat belt and child safety seat use by conducting seat belt and child seat safety inspections and community education activities; and

**WHEREAS**, the City Commission finds and determines that it is in the best interest of the City to accept the grant funding for seat belt and child safety education and enforcement activities.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA:

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution.

<u>Section 2:</u> That the City Commission hereby accepts the FDOT FY26 Occupant Protection and Child Passenger Safety Grant in the amount of forty thousand dollars (\$40.000).

<u>Section 3:</u> That the City Commission has reviewed and hereby approves the attached agreement between FDOT and the City of Coconut Creek for the Occupant Protection and Child Passenger Safety Grant.

<u>Section 4:</u> That the City Manager, or designee, is hereby authorized to execute said agreement between FDOT and the City of Coconut Creek for the Occupant Protection and Child Passenger Safety Grant.

<u>Section 5:</u> That if any clause, section, other part or application of this resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect the validity of the remaining portion or applications of this resolution.

**Section 6:** That this resolution shall be in full force and effect immediately upon its adoption.
