

ORDINANCE NO. 2026-020

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF COCONUT CREEK, FLORIDA, AMENDING THE CITY'S CODE OF ORDINANCES, BY AMENDING CHAPTER 15, "PARKS AND RECREATION," ARTICLE II, "RULES AND REGULATIONS," TO AMEND SECTION 15-30, "PARKS FACILITIES AND USE FEES," DELETE SECTION 15-34, "SPECIAL ACTIVITY INSTRUCTORS/ ADMINISTRATORS," AND AMEND SECTION 15-37, "VIOLATIONS AND PENALTIES," TO PROVIDE FOR ADOPTION OF THE SCHEDULE OF PARKS AND RECREATION USER AND SERVICE FEES BY RESOLUTION OF THE CITY COMMISSION, REMOVE ACTIVITY INSTRUCTOR FEES FROM THE CODE OF ORDINANCES, TO BE ADOPTED WITHIN THE SCHEDULE OF PARKS AND RECREATION USER AND SERVICE FEES, AND UPDATE VIOLATIONS AND PENALTIES CONSISTENT WITH THESE CHANGES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission recognizes that changes to the adopted Code of Ordinances are periodically necessary in order to ensure that the City's regulations are current and consistent with the City's regulatory needs; and

WHEREAS, the City desires to update the schedule of fees for parks and recreation facility rental, memberships, and program fees to ensure alignment with current operational costs, fees in comparable municipalities, and the City's commitment to delivering high-quality programs and services; and

WHEREAS, the City Commission has determined that it is more efficient and less costly for the City to amend the schedule of fees by resolution; and

WHEREAS, the City Commission desires to amend the fees as needed by resolution; and

WHEREAS, the City Commission has considered the amendment in its entirety, and determines the amendment is in the best interests of the City.

NOW, THEREFORE, THE CITY COMMISSION OF THE CITY OF COCONUT CREEK HEREBY ORDAINS:

Section 1: Ratification. That the foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this ordinance.

Section 2: Amendment. That the Code of Ordinances of the City of Coconut Creek, Florida, shall be amended by amending Chapter 15, “Parks and Recreation,” Article II, “Rules and Regulations,” to read as follows:

Chapter 15 - PARKS AND RECREATION

ARTICLE II. – RULES AND REGULATIONS

Sec. 15-30. Parks facilities, and use, and activity fees and rates.

The fees, rates, and cost formulas for park or facilities rental, ~~and/or~~ parks programs, special activity instructor, and special activity/league administrators shall be set forth on a schedule of fees available in the parks and recreation department adopted by resolution by the City Commission.

Sec. 15-34. ~~Special activity instructors/administrators~~ Reserved.

(a) ~~Special activity instructors shall share the gross revenue generated by special activity classes according to the following table:~~

	Instructor	City
Park facility use	80%	20%
Noncity facility use	85%	15%

(b) ~~Special activity/league administrators shall share the gross revenue generated by special activity leagues according to the following table:~~

	Administrator	City
Park facility use	70%	30%
Noncity facility use	80%	20%

Sec. 15-37. Violations and penalties.

It shall be a violation of this article for any person to fail to pay the ~~charges herein specified~~ Parks and Recreation User and Service Fees established by resolution of the City Commission or to violate any of the terms and conditions ~~herein of this article~~. Any person convicted of violating the provisions of this article or failing to pay required User and Service Fees shall be punished by a fine of not less than fifty dollars (\$50.00) but not to exceed five hundred dollars (\$500.00), or by imprisonment not exceeding ninety (90) days, or by both. Fines for nonpayment of User and Service Fees shall be in addition to payment of the required fee.

Section 3: Conflicts. That all ordinances or parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions or parts of resolutions in conflict with this ordinance are hereby repealed to the extent of such conflict.

Section 4: Severability. That should any section or provision of this ordinance or any portion thereof, any paragraph, sentence, clause or word be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remainder hereof as a whole or part hereof other than the part declared invalid.

Section 5: Codification. That the provisions of this ordinance shall be codified within the Code of Ordinances of the City of Coconut Creek, Florida, and any paragraph or section may be renumbered to conform with the Code of Ordinances.

Section 6: Effective Date. That this ordinance shall become effective upon its passage on second and final reading.
